

## ANCHORS UP RESCUE GROUP FOSTER AGREEMENT

The parties hereto agree that the owners shall abide by the following conditions: NAME the dog, hereinafter referred to as the dog, is being transferred to the foster: NAME ADDRESS with the understanding that the foster is taking temporary possession of the dog, to treat and to be responsible for it as their own dog, until Anchors Up Rescue Group regains possession of said dog. The dog will be treated as a family member with loving care and affection. I will do my best to ensure the dogs safety and well-being. I/we will feed the dog at least twice a day and will provide a fresh supply of water at all times. The dog will live inside my home and will not be isolated from the family. I will take him with me shall I be gone longer than 10 hours. I will NEVER let my foster dog run loose or roam, keep him/her chained, caged or tied up, keep him/her continuously in a yard, garage, patio, balcony, or pen, or leave my dog outdoors, even in a fenced yard, when no one is at home. I will not use him for any purpose other than companionship. I understand that my duty in this foster arrangement is to assure the safety and comfort of said dog. I will not have the dog's ears cropped nor will I have its tail docked. I will not alter the dog in any way other than monthly grooming upkeep. I will never allow any physical, mental, or emotional abuse of the dog.

I/we affirm that no member of my household has been convicted of an animal welfare law violation such as neglect, cruelty, abandonment etc. I will attach the appropriate license tags, rabies tag, AURG (Anchors Up Rescue Group) tag, and personal identification tag to a comfortable non-choke collar to be worn at all times. I will ensure compliance with all applicable local and state statutes. I am fostering the dog for AURG and I agree to not give away, sell, or trade the dog, even as a gift to a friend or family member. I will neither take the dog to a shelter nor abandon him. I understand that I **must** notify AURG, without delay, if I can no longer care for or keep my dog and agree to give AURG reasonable time to rehome my dog or place my dog in a different approved foster home, if available. I must notify AURG of any behavioral problems that have occurred at any time before I return my dog. In the event the dog becomes lost or dies, no matter how long I have had the dog, I will immediately notify AURG. I will also immediately notify AURG of any change of contact information (address, phone number, or email address). This dogs known background and medical history have been discussed with me. I understand that AURG has made no representation concerning the health, condition, training, behavior, or temperament of the dog. I agree to permit AURG to make inquiry about and enforce any of the above conditions and requirements at any time after adoption. This can include visits to my home and contact with my veterinarian. I UNDERSTAND THAT FAILURE TO COMPLY WITH ANY OF THE ABOVE PROVISIONS WILL RESULT IN FORFEITURE OF THE DOG TO AURG and possible lawsuits if it is found to be neglectful behavior. I understand that by voluntarily signing this agreement, I am entering into a legal and binding contract with Anchors Up Rescue Group. Breach of any term(s) of this agreement is deemed actionable by AURG. In the event, there is a violation of the agreement, I agree to pay a minimum of \$500.00 in damages. Additionally, in order to facilitate the collection of damages for breach of contract, I waive any challenge to venue and agree that the appropriate venue for this matter Clark county Nevada. Furthermore, I agree to accept service of process by certified mail, return receipt requested, to the address provided in this adoption contract, and specifically waive any right to receive personal service.

By signing, I am agreeing to the terms and conditions outlined in this document and promise to adhere to them for the well-being of NAME the dog.
